We filed 6 of the initially filed 19 cases on day 1 as reported by the court (2 PI requests, 4 main infringement actions and many protective letters). They include the very first cases filed at the Munich and Hamburg local divisions as well as the Munich central division. We defend in 1 additional case.

In total, we are handling **7 of the current 20** cases with a share of a bit more than **1/3**.
